### Infrastructure / Improvements / Funding

City funded

State funding (COAR), PMP, 5010

State of OR told Randall that Seaside is probably not going to get pavement management this year. Mike will call state ODA staff representative to follow up

Federal & CIP - no update

Hangars

Randall has talked to a local developer and other interested parties, and there continues to be plenty of interest from people who would buy or rent. Need to fill in this developer and possibly others on what it would take to do it. Drawing/plan exists for 7 bay T hangar building on grass area east of the shed, and received preliminary approval from FAA.. Other locations still viable e.g. the west and north fencelines, would be up to any developer.

Grants / Port / Other – committee recommendation from last meeting remains i.e. committee has recommended that the city apply for a grant for fencing in NW area along Bayview and Oster road.

### Maintenance / Safety / Security

Airside - runway / taxiways, windsocks beacon, runway lights, reflectors - some reflectors are out and could be replaced which are in the shed

Discussion around beaver dams

Should we add dredging of the ditch to the CIP list? Probably.

What about beaver deceivers? Mike to look into it. Recommendation to talk to Noah at Watershed

# Council.

Mike's team still needs to install runway lights (safety item).

Flooding and driftwood – Driftwood has been removed.

Groundskeeping – Vegetation (primarily off runway ends) needs to be addressed per ODA inspection. Mike's team will mow, weed eat around runway lights, and spray weeds, especially on taxiway Cameras / website / internet – status, funding, FAA integration – The Seaside Airport is now on the FAA map! Check out weathercams.FAA.gov website. A third camera was added, thanks Tim Miller! Trespass – none observed.

Condition of gates, locks, fencing, signage – Lock on ped. Gate is inop., needs replacement. Mike's team will look at it.
